The FVEAA Seminar has preempted the April meeting. The regular third Friday is on Easter weekend and it seems prudent to cancel that meeting.

We are going ahead with the Seminar after much reconsideration. ComEd's late withdrawal of the event notice that was to be in 3-million customer bill enclosures threw the project into disarray. With it there was no need for publicity. Without it we have to scramble. Press releases were sent to 29 newspapers, TV & radio stations with no response. Probably a war casualty. I was on the verge of canceling the Seminar. The persuasive efforts of Ted Lowe and others changed my mind. He has issued an invitation to his many acquaintances, and that convinced me to go ahead.

Instead of holding the Seminar in the 400-seat Collins Auditorium at Triton, it may be shifted to Room 106 in the Industrial Careers Building. The 110 seats in that room are arranged theater style. If on-line registrations unexpectedly pick up in the next two weeks we can shift the Seminar back to Collins. Every politician and restaurant owner knows not to put a small audience in a large room.

There will be a special opportunity on Saturday, April 12<sup>th</sup> to see a copy of the *Wright Flyer* now on display at the Smithsonian. Various groups around the US will commemorate the 100th anniversary of the first flight by constructing four copies of the original airplane. One team is at Clow Airport in Bolingbrook. FVEAA Director Ed Meyer is a member of that team and issued the invitation to the FVEAA.

If you want to see this interesting project drive to the Airport restaurant parking lot and go to Hanger 3 where Ed will be waiting to greet us. Arrival time is 10AM. You can also go to the web under "Wright Flyer Redux". It is on both Google and Yahoo. Lots of pictures.
