President's Words

John Emde has promised that, as available, he will try to add to our meetings by giving a short discussion of a particular component of EV's. Many EV's use a potentiometer, called a pot or a pot box to signal how far the accelerator pedal is pressed. Many controllers, including the venerable Curtis, use a 0 to 5 K pot box for this input. John will tell us what a 0-5K pot means, what resistance it should measure at certain pedal openings, and how smoothly it should show differing resistances. Lately, we have found several EV's with a rather sudden onset when the accelerator pedal is slowly pushed, and John will explain why that might be happening to you.

A new bill has been introduced into the US House of Representatives by Judy Biggert, R-13th Dist, Hinsdale, IL. HR 1685 is a comprehensive bill to establish EV deployment areas, either in municipal groups or in corridors. The stated objective of the bill is "To establish programs to accelerate, provide incentives for, and examine the challenges and opportunities associated with the deployment of electric drive vehicles, and for other purposes."

Next the bill is referred to several committees for comment, then back to the US House for a vote.

It may have significant wording changes from the input of other committees and other Representatives.

There is a lot of interesting things in this bill, and the strong possibility is that some amendment(s) will add some additional positive or negative features. Please keep posted on this bill, as it is quite likely to affect the EV community significantly.

Essentially, this is a bill to facilitate and fund rapid, near-term deployment of electric vehicles in established deployment communities. These deployment areas must demonstrate consumer benefit, with a minimum of "\$2,000 in benefits to each of the first 50,000 consumers who reside in the deployment community who purchase electric drive vehicles." Phase one will have ten deployment communities in the USA.

• Other parts of the bill offer:

- Tax credits for various refueling (charging) options
- Establishment of electric vehicle refueling (charging) property bonds
- money for infrastructure planning
- Loans for electric drive component manufacturing
- Loan guarantees for advanced battery purchases, including those used for stationary purposes

This is a little unusual in that the bill is sponsored by a Republican: <u>Rep. Judy Biggert [R-IL13]</u>

Meeting Minutes - June 2011

The meeting started promptly at 7:00 p.m. and everyone who was there early introduced themselves. Tonight we have six electric vehicles to view at the break.

COMMITTEE REPORTS

OUTREACH - Rich Hirschberg mentioned several cruise nights are listed on the forums, including Eco Fair 360 festival in Walworth county July 8 – 10, the Midwest Renewable Energy Association in Custer Wisconsin this weekend. And in July, the Hybrid fest at the Madison fairgrounds.

NEWSLETTER – Keith Baubkus had no news. FINANCIAL ASSISTANCE – George was not present to report. PROGRAM – Bruce Jones had no news.

TREASURER – Todd Dore said the FVEAA has plenty of money in treasury and then gave a report on the GREEN FEST May 14 – 15 cost around \$3300 and was within budget. There

were two other seminars going on at McCormick Place and the Green fest was better attended. We had a very well constructed booth, which was well attended, and Todd Dore did an excellent job managing the entire project.

BATTERY SURVEY

Rich Carroll surveyed the audience on the batteries used in their EVs and approximate miles they provide. He received a wide variety of answers, with members noting mileage was reduced quite a bit in the Winter

NEW BUSINESS

PIKE'S PEAK EV

June pike's peak race had an electric car attempt the course last year and had a record run. The electric car took only 14 minutes which was an excellent showing for an EV.

SIERRA CLUB

Ted Lowe mentioned that the Sierra club with a million members is starting an EV campaign, and for outreach they want the FVEAA to be a partner.

STRANGE STORY

Rich mentioned the Chicago Electric Vehicle Consortium was originally charged with helping plan the rollout of charging stations in Chicago as part of the \$14.99M grant. The first part of the rollout included \$1.1M plus \$.9M matched by the state of Illinois rollout in new charging stations. The rollout includes 207 level 2 chargers plus 73 high speed DC quick charging stations. 350Green, the company won the bid by providing \$2M of services plus \$6.8 of additional stations. Ten percent of the chargers were to be installed by December and 30% by March. It appears 350Green has not achieved the goals or answered questions however. Rich then described a recent meeting of the National Battery Alliance where, after the end of the meeting, executives of 350Green entered and were instantly surrounded by venture capitalists and others with many questions.

Rich also fielded many questions about the situation and stated that, unfortunately Chicago's commissioner of the environment and 1st deputy commissioner were not retained by the new City administration, even though it appeared they had been doing a good job. Rich also mentioned the CEVC had served its purpose and the City is now using an industrial municipal consultant Roland Burger with Antonio Benici to help with the rollout.

PLUGS

Two 25' cables were shown with J-1772 plugs, but the FVEAA has not made any decision on where to install them.

BREAK

Six Electric Vehicles were on display.
