

The announcement by Hunter Hamstra and Net Gain Motors at the July meeting is a game changer in the EV conversion market.

As most are aware, all of the successful, commercial EVs in mass production in the past 20 years have been AC powered. AC motors must be carefully matched to their controller/inverter, and should be thought of as a package. There hasn't been a reasonable package for AC motor and controller in the conversion market in the past. Yes, a \$2,500 motor and \$5,000 controller would have been possible, but most considering a conversion looked at DC motors (just under \$2,000) and controllers that were in the \$2,500 - \$3,000 range. Thus, the major components (motor/controller/pedal) started any conversion cost at close to \$5K, plus batteries.

This new HyPer 9 with an inverter/controller/motor/pedal combination for about \$4,000. Are there advantages, other than the lower price? You betcha.

Better efficiency, better heat dissipation, easily controllable regenerative braking are high on the bullet points. The entire package can be fairly easily adapted to many possible conversions. The suggested system voltage of 120 V (130 absolute max) means a slightly different approach to battery pack specifications, but allows for somewhat less expensive components like the DC/DC converter used to take traction battery voltage and make 12V+ for automotive systems like headlights, fans, wipers, radios, etc.

Hunter reports he shipped a motor and controller to EV West (who has done several VW beetle EV conversions) and by adapting a Beetle differential (Type 1) to a very tired VW panel truck, they were able to get the truck running (and doing burnouts) three days later. That's starting from a truck that crashed against a fig tree years ago, dragging it out of where it was buried next to the fig tree, and repowering it with Lithium and the new HyPer 9. Fortunately, he did not measure or report the force of the acceleration burnouts, as the units likely would have been in multi fig-kilo-newtons.

With more efficiency, more range, less heat waste, lowered component price for DC/DC converters, regenerative braking, and a substantial saving in initial cost, why would you consider starting a DC conversion?

Ken Weger's Small Wonders Museum houses over 100 microcars, most are completely unfamiliar to the automotive public. These are truly tiny automobiles, most are much smaller than common cars of today, but

many are capable of highway speeds. Ken Weger has agreed to give us a focused presentation of the battery powered microcars, a most unusual opportunity.

On the same night, NEDRA (National Electric Drag Racing Association) has arranged for many of the leading electric powered dragsters in the country to race nearby in Michigan. Midnight Madness will occur, also this Friday, from 6pm to midnight (local times) at the US 131 Motorsports Park in Martin, MI. The track is north of Kalamazoo, about a three hour drive from Chicago. 

- President Mike Willuweit opened up the meeting and introduced himself.
- Those in the audience then Introduced themselves including George Hamstra and his son Hunter

### NetGain Motors

- Hunter from NetGain was the featured speaker who presented what the company has been doing to develop new electric motors over the last 4 years.
- The talk included many awards for their motor achievements, and the new HyPer 9 AC motor which is a 100v nominal Voltage, Current 750 amps, 173 ft. lbs of torque at 0 rpm, weighs 120 lbs 3 phase motor with regeneration, along with the Controller
- NetGain Motors signed a worldwide agreement with SME for non-production electric vehicles and distribution of other items
- SME a manufacturer of controllers and motors is headquartered in Italy but has offices in China and Canada
- Hunter described their Synchronous Reluctance motor

- completely sealed
- generates almost no heat in the rotor
- 95% efficient (versus AC induction 92%)
- Hyper 9 motor and Controller production this Fall
- George suggested coming out on Friday Aug 18<sup>th</sup> to the U.S. 131 drag strip in Michigan (north of Kalamazoo) for some exciting NEDRA electric vehicle racing
- Discussions with the group on various aspects of the motors
