#### **FVEAA** Meeting Minutes for 12/19/08

President Ted Lowe called the meeting to order at 7:01pm. There were introductions from new attendees and guests.

**Old Business:** 1) Ted made a pitch to join the National EAA (Electric Auto Association) - you get a periodic newsletter (Current Events) with a bumper sticker. 2) Ted mentioned that FVEAA shirts are for sale - for \$16.50 each. 3) Ted is looking for articles and literature - materials for our monthly newsletter. 4) Committee reports - [A] Todd Dore spoke on Legislative Affairs. He encouraged everyone to write to your state senator to get NEVs allowed on IL roads. House Bill HB5006 IL was approved earlier in the year which was the approval vote from the IL House. The Chicago City Council is also voting to allow NEVs on roads in the city - the Chicago Clean Cities Coalition is pushing for this. Ted will look into the possibility of the FVEAA being involved in an awareness campaign. [B] Outreach - Rich Hirschburg - Thursday, January 8th, 2009 there will be a seminar at Illinois Benedictine College called the DuPage County Environmental Summit. #### **ELPC Campaign for Illinois Clean Cars Act**

The Environmental Law & Policy Center of the Midwest (ELPC) is currently working on a campaign to bring Clean Cars to Illinois. Illinois has the opportunity to become the 15th state to pass legislation that will ensure all new passenger vehicle and light-duty trucks will be more efficient and emit lower levels of air pollutants. This change will improve public health, save Illinois consumers money at the gas pump and help in the fight against global warming. The Illinois Clean Cars Act is coming up for vote in the Illinois House of Representatives this November, as House Bill 3424. The Act will raise the average fuel efficiency standard for new vehicles sold in the state to 39.6 mpg. ELPC is asking constituents to contact their Illinois House Representative to tell them to vote YES for this bill. Clean Car Organizers was present at the September 19 monthly meeting and gave a presentation about the bill and got petitions signed in support of bringing clean cars to Illinois. #### **Book Review: Build Your Own Electric Vehicle, 2nd Edition**

The second edition of Build Your Own Electric Vehicle is an updated version of the original book by Bob Brant. While it covers such things as environment, politics and history, most importantly, the book covers the information you need to start an electric car project. I'd recommend that you read this before you start your conversion, then use it as a reference book when you go shopping for components. It brings you up to date on the many improvements that have been made in EV technology over the past decade. The information is both general and specific, and some is already outdated. There is plenty of math to help you to understand the reasons for the different options and decisions that need to be made, but if you do not need that form of understanding, the book gives a summary after each section of the best choices. This book will guide you through the EV building process, whether doing it yourself, if you have the mechanical skills, or knowing what should be done if someone else will be doing the job.

If only I had this book 29 years ago!!
