President's Words

Several interesting things have come up at the Chicago Electric Vehicle Consortium meeting in late February. The initial step towards charging stations is to focus on 44 stations throughout Chicago, with the focus on quick implementation. Current thinking will be to use Level 2 charging as the initial standard, so all 44 charging station should be J-1772 compliant, 30 or 40 amps, 220V. Requests for information have been sent to known vendors of charging stations. Requests for actual proposals will follow. It is hoped to have actual presentations of working charging stations by late April or early May. I had suggested that the meeting for the presentation of these charging stations be moved to a City of Chicago garage, or a ComEd facility. The committee was most interested in making sure that the boxes shown were real, and not just mock-ups.

The locations are yet to be determined. Several local businesses and colleges have expressed interest in having a charging station, and the committee is charged with a city wide distribution.

The particular J-1772 configuration has not been chosen yet. The committee plans to wait until vendors do their presentations to see what configurations are shown. No action has been taken on Level 3 charging stations, as no standard has been published.

Several considerations have been voiced over ways to incentivize the program. Some of these make it less expensive to own and operate an electric car in Chicago. Some of these will make owning an electric car more desirable, such as guaranteed parking places. Some of these will make it easy to obtain permitting for charging stations. Some of these will offer financial incentives to EV owners. No final list has been published for the various proposed incentives, although there should be specific programs proposed very soon.

In other areas of interest, the Earth Day programs seem to be popping up everywhere. I have about a half a dozen invites on my desk, but most of them seem to be programs done with good intentions, but of little substance. Some municipalities seem to feel that putting together an exhibit of several vendors who can promote their cause with a 'green' slant is a great start for a good program. it isn't.

A good 'green' program is:

- a program that educates the public
- promotes local involvement in environmental saving
- helps connect people wanting to help with projects that need peoplepower
- one that can be accomplished by people with very limited financial investment

A program that costs the public money to see, and has local groups promoting their own cause or their business doesn't necessarily promote 'green issues.'

Meeting Minutes

FVEAA meeting notes February 2, 2010

Rich Carroll opened the meeting at 7:00 p.m. with some Housekeeping and Publicity items after everyone present introduced themselves.

Open Discussion

Many subjects were brought up including the Chicago Electric Vehicle Consortium, the topic of whether a charging plug might being pulled from an electric car and plugged into

someone else's car, the Nissan leaf and Chevy volt availability in Chicago, power levels and plug types, adapters, and the drive off/breakaway ability of the fuel cable.

Committee Reports

Financial Assistance - George Vergara

George created and brought with him a plan for getting grants & funds, and suggested we get a subscription to the donor's forum for researching grants.

Finance - Ted Lowe

Ted gave a fine presentation on the financial status of the club to be included in the 501(c)3 application to be submitted next month. It was suggested that we do not put any more money into Avcon charging stations since it's older and not the wave of the future. The EAA matched funds last year, around \$2100 for installing charging stations, and we would now like to be consistent with charger decisions made by the Chicago EV Consortium if possible. Immediate goal is to consider ways to use the funds and possibly buy equipment to facilitate charging

our own vehicles when we attend shows, or allow borrowing stations from the club as needed.

We are still in talks with Chicago State University about putting in a charging station

Legislative Affairs - Howard Hansen

Illinois Secretary of State in some cases requires electric vehicle owners to send a picture of their car's electric engine to verify it is electric.

New Business

Illinois Green Fleets

Howard Hansen discussed the rebate from Illinois green fleet as part of the Illinois Alternate Fuels Rebate Program. The Illinois EPA will be issuing rebates for approved applications for the 2009 program year based on the amount of funding available in the Alternate Fuels Fund.

The Illinois Alternate Fuels Rebate Program is available to any resident, business, local government or organization in Illinois. It offers rebates to anyone using E85 or biodiesel fuels (20% blend or higher), and for acquiring vehicles that run on alternate fuels. All E85 and Biodiesel Fuel Rebate applications for 2009 were to be submitted by January 31, 2010 for consideration. Rebates could take up to five months to be issued. IIT Zinc Air Battery Presentation

David Fairbanks from the Illinois Institute of Technology gave an excellent presentation on their recent research, and how they were retrofitting a couple of Chevrolet S-10 pickups donated by Argonne Laboratories with Zinc air batteries. (a recent article on Zinc-air batteries in the recent Popular Science magazine noted Zinc-air has the potential to be up to 10 times more potent as Lithium-ion batteries) His presentation about the CZAR CAR using refuelable electric Zinc air batteries is now posted on the FVEAA web site.

Raffle

Howard Hansen was raffle meister for the 6 in 1 all in one keychain screwdriver, Plug-in Vehicle Solutions Tshirts and Quick car shine wipes

Tesla

Three Tesla electric sports car enthusiasts Sam Carnavacciolo, Carl Walters and Steve Schnur

drove their cars to the meeting and displayed them for the members. Next month they have offered to give rides if the weather cooperates, so we will probably be raffling off rides at the break next meeting on March 19!

Naperville Green Efforts - Robert Fieseler

Robert Fieseler, Naperville City Councilman gave a presentation on renewable efforts in the city of Naperville. He started by discussing Hydrogen as a fuel and demonstrated a fuel cell hydrogen powered car model. Naperville's municipal electric system is owned and run by Naperville, and they are implementing a Hydrogen system at the Jefferson St. fueling station. The station was purchased for \$1 from BP when they were exiting the Hydrogen business. The site will be recommissioned by Air Products with advice from partner Argonne laboratories. He mentioned the Naperville Smart Grid grant (Federal \$ 11M plus matching \$11M) which will be the topic at the FVEAA meeting in March.

Based on another grant, The Green Fuels Depot will convert leaves and grass picked up from Naperville residents, and converted to SynFuel at the 95th street waste water treatment facility. So instead of dumping the biomass in a landfill creating methane gas, it will be used to power city trucks. Several groups are involved with this, including Peter Schubert of Packer Engineering (the building we meet at!), Argonne labs, and the College of DuPage who will deploy gassifiers for the beta site. They are also involved with the Department of Energy which has a fleet of 10-15 plug-in hybrid vehicles being tested under extreme weather and the Chicago area is a good place for that

Bob stressed that job creation is an important priority. Naperville is currently purchasing energy through a Goldman Sachs contract up in 2012 then they'll use the new prairie state coal fired plant down state for a 20 year contract. Naperville is a 40% participant in the coal plant contract. This subject sparked a lot of conversation by the audience. Bob also believes Hydrogen is going to be the next energy source in 20 years.

Rich Carroll ended the meeting at 9:25 p.m.
